THE BLEDSON COUNTY COMMISSION MET IN A SPECIAL CALLED SESSION JUNE 20, 2023 AT 7:00 P.M. IN THE HONORABLE JUDGE EDWARD H. SAPP COURTROOM. PRESENT AND PRESIDING WERE CHAIRMAN JOHNNY MACK SWAFFORD, MAYOR GREGG RIDLEY, COUNTY CLERK GENESE SAPP, SHERIFF JIMMY MORRIS AND DEPUTY JARRETT SAPP.

UPON MOTION BY COMMISSIONER ROBERT REECE AND SECONDED BY COMMISSIONER RONNIE SAPP TO APPOINT JOHNNY MACK SWAFFORD TO THE NURSING HOME BOARD PASSED BY A VOICE VOTE.

UPON MOTION BY COMMISSIONER JUNIOR HANKINS AND SECONDED BY COMMISSIONER SHAWNA FARMER TO APPROVE THE RESOLUTION AUTHORIZING BLEDSON COUNTY MAYOR TO APPLY FOR A COUNTY CREDIT CARD PASSED BY A 13 YEA VOTE.

UPON MOTION BY COMMISSIONER HEATH HUDSON AND SECONDED BY COMMISSIONER ANDREW SWAFFORD TO ACCEPT THE RESOLUTION MAKING APPROPRIATIONS FOR THE VARIOUS FUNDS, DEPARTMENTS, INSTITUTIONS, OFFICES AND AGENCIES OF BLEDSON COUNTY, TENNESSEE FOR THE FISCAL YEAR BEGINNING JULY 1, 2023 AND ENDING JUNE 30, 2024 WITH THE CHANGES IN THE GENERAL FUND BUDGET BEING: JAIL-INCREASE 101-54210-105, DIRECTOR/SUPERVISOR, \$59,296.00, DECREASE 101-39000, UNDESIGNATED FUND BALANCE, \$59,296.00 AND JAIL-INCREASE 101-54210-165, CAFETERIA PERSONNEL, \$48,988.00, DECREASE 101-39000, UNDESIGNATED FUND BALANCE, \$48,988.00 PASSED BY A 10 YEA VOTE.

UPON MOTION BY COMMISSIONER RUTH BURTON AND SECONDED BY COMMISSIONER TANYA ROBERSON TO APPROVE THE RESOLUTION MAKING APPROPRIATIONS TO NONPROFIT CHARITABLE ORGANIZATIONS OF BLEDSON COUNTY, TENNESSEE FOR THE FISCAL YEAR BEGINNING JULY 1, 2023 AND ENDING JUNE 30, 2024 PASSED BY A 13 YEA VOTE.
