THE BLEDSOE COUNTY COMMISSION MET IN REGULAR SESSION ON JULY 18, 2022 AT 7:00 P.M. IN THE HONORABLE JUDGE EDWARD H. SAPP COURTROOM. PRESENT AND PRESIDING WERE COMMISSION CHAIRMAN MATTHEW COLVARD, MAYOR GREGG RIDLEY, COUNTY CLERK GENESE SAPP AND COUNTY ATTORNEY HOWARD UPCHURCH.
